Cannot Accept List

We may decline a donation if it is not in clean or in saleable condition or if we are unable to assist with larger items due to risk of injury. Our volunteers will help unload donations, however, cannot help if (in their judgement) doing so may damage any vehicle, or if doing so is unsafe for them or anyone else.

We are unable to accept the following due to legal or liability risks, safety or hazardous/universal waste concerns, recycling and/or disposal fees:

Air Conditioners or other freon-containing appliances

Ammunition or Weapons including BB guns, pellet guns, and arrows

Appliances, Large stoves, ovens, refrigerators, dish washers, etc.

Automobile Parts

Baby Equipment

Bed Pillows

Bike Helmets, Used

Bunk Beds

Chemicals household or industrial

Construction Debris

Copiers, Large Standing

Exercise Equipment, Large treadmills, Bowflexes, elliptical machines, etc.

Fishing Tackle

Flammable Liquids/Gases lamp oil, gasoline, propane, kerosene, sterno, butane, etc.

Furniture, Damaged unsellable or broken condition

How do I get a tax receipt for my donation? All your donations to GFGF are tax deductible. You will receive a receipt when you donate your items.

What is the IRS value of my donation to GFGF? The IRS allows you to deduct fair market value for gently-used items. If you're not sure what your donation might be worth, please refer to the IRS table .

What will you do with items that have not been sold? Arrangements will be made for Purple Heart and Habitat for Humanity to pick up all unsold items from the Grange.
